2. Minutes of the last Meeting

3. Update Plan for 2020

Plan C No Parade, record the Bugler and the Reading at the memorial in Heath Hayes & Wimblebury

At 11am on Sunday, 8th November 2020 the Parish Council will broadcast a pre-recorded service on the Heath Hayes & Wimblebury Parish Council Facebook page and website. The Council agreed to live stream the services from the Bourne and St Johns Church, depending on their own arrangements and with their agreement.

The Clerk would write to everyone involved advising of the new plan and invite them to participate by either emailing photos of past events that they had been involved in and current photos of their groups, they could choose a couple of representatives to lay a wreath, video in landscape and forward the clip to the Clerk, this could be done at either Heath Hayes Memorial Gates or Wimblebury Memorial, this may be done at any time convenient to themselves, they would be asked not to leave their poppy wreath at the memorial but to bring to Hayes Green Community Centre on a Monday or Tuesday morning and we would arrange for it to be laid on their behalf on Sunday 8th November.
