
<p><b>Contracts</b></p> <p>(any contact which is made between the relevant person (or body in which the relevant authority:-</p> <p>(a) Under which good or services are to be provided or works are to be executed and</p> <p>(b) Which has not been fully discharged.</p>		
<p><b>Land</b></p> <p>(Any beneficial interest land which is within the area of the relevant authority)</p>		
<p><b>Licenses</b></p> <p>(Any license (alone or jointly with others) to occupy land around the relevant authority for a month or longer.</p>		
<p><b>Corporate tenancies</b></p> <p>(Any tenancy where to your knowledge)-</p> <p>(a) the landlord is the relevant authority and</p> <p>(b) the tenant is a body in which the relevant person has a beneficial interest.</p>		
<p><b>Securities</b></p> <p>(any beneficial interest in securities of a body where</p> <p>(a) the body where to your knowledge has a place of business or land in the are of the relevant authority and</p> <p>(b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body: or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>

(B) A decision in relation to that business might reasonably be regarded as affecting your wellbeing or financial position or the wellbeing or financial position of a relevant person to a greater extent than the majority of council taxpayers, rate payers, or inhabitants of the electoral ward affected by the position.
